COMMITTEE REPORTS

FINANCE & ECONOMIC DEVELOPMENT

Deputy Mayor Randell reported that the committee reviewed aged receivables and hours of operations.

58-21 Randell / Cormier be it resolved that the Town of Pasadena approve accounts payable listing for cheque #035938 to 036024 in the amount of \$187,693.08.

WORKS & PLANNING

Councillor Brake reported work on Tipping Drive water line installation has started, South Brook hiking trail is now officially opened and review of animal control regulations will soon be completed.

RECREATION & COMMUNITY SERVICES

Councillor Walsh reported on the following items: purchase of Pride Flag and Pride benches; splash pad to go to tender this Fall; student grants have been received; accessible washroom is completed inside and summer program is almost filled. Councillor Anthony advised that access to the boat launch is temporarily through Lakeshore Drive due to construction on Tipping Drive.

Councillor Cormier asked if the boat launch pad has been put in place. He was advised that it has not.

Deputy Mayor Randell asked if there are any plans for Canada Day. He was advised that there is nothing planned to date, however, there will be a few virtual activities taking place.

CHIEF ADMINISTRATIVE OFFICER REPORT

Mr. Hudson reported on the following items: Tipping Drive is progressing on schedule; THM project is ongoing and the pilot project has been completed; Main Dam is under design, and office staff are reviewing vote by mail procedures for the election on September 28, 2021.

He attended the official opening of Missing and Murdered Indigenous Women and Girls commemorative garden at the Majestic Lawn in Corner Brook and encouraged people to go visit this site.
