#### **COMMITTEE REPORTS**

#### FINANCE & ECONOMIC DEVELOPMENT

Deputy Mayor Randell advised that the Committee met on December 13, 2021. Items they discussed where: conflict of interest; auditing process; human resources and branding. Deputy Mayor Randell presented the following resolution.

# **WORKS & PLANNING**

Councillor Cormier advised that they met with the Fire Chief and Deputy Fire Chief and discussed a few issues such as how they can manage the budget a little better in the future. The committee also met with Director of Public Works and items of discussion were: a few issues with lagoon that will be corrected in the Spring; water leaks; snow clearing equipment is in good working condition; Municipal Enforcement Officer is doing great work in town; we now have filters at our lagoon that can detect Covid-19 which will help both our community and Department of Health with the fight against Covid.

160-21 Cormier / Walsh be it resolved the Town of Pasadena approve an application for a home based business "Holistic Consulting Ltd." to be located at 38 Bowater Boulevard, subject to all home based business regulations, off street parking and one customer at a time.

Council acknowledges a cost over run from current funding allocations and will fund through means available to Council.
