Many grants have been approved and many more applied for.

Councillor Brake advised that the trails are in need of repair and it will be started as soon as time permits.

Mr. Hudson advised that the fire department has applied for funding through the Provincial Cost Sharing Program. The closing date of three positions with the Town was March 17 and very encouraged by the great amount of applicants.
