COMMITTEE REPORTS

FINANCE & ECONOMIC DEVELOPMENT

Deputy Mayor Randell advised that the committee met on February 28, 2022. Items discussed were economic development; Rules of Procedures for Council; Human Resources and working on new Terms of Reference for Committees of Council.

22-21 Randell / Decker be it resolved that approval be given to adopt updated Pasadena Rules of Procedures Governing Meetings and rescind any previous Rules & Procedures.

WORKS & PLANNING

Councillor Cormier advised that the committee met on February 28, 2022. Items discussed were fire protection for Humber Valley Resort; repairs to fire hall; saw mills; storm sewer for Tamarack and Forest Road; splash pad and community pool.

- Cormier / Hall be it resolved that the Town of Pasadena approve a temporary policy to allow residential sawmills until such time amended development regulations are implemented. Residential sawmills will be temporarily permitted with the following conditions:
 - Shall be located in an enclosed accessory building
 - Maximum noise level of 65 dB at property boundaries
 - Use of operation limited to 9:00AM-4:00PM
 - Limited to personal use/no sale of product
 - Sawmill by-product/waste to be removed weekly
 - Annual permit review/renewal and fee of \$25

Cormier / Hall be it resolved that Council approve the following revised 2020-2023 Multi-Year Capital Works: MYCW 2020-2023 Street Reconstruction in the amount of \$796,572.74 and MYCW 2020-2023 Seaward Park Upgrades in the amount of \$680.126.00.

25-21 Cormier / Hall be it resolved that Council approve the following revised 2017-2020 Multi-Year Capital Works: Street Reconstruction 17-MYCW-19-00071 in the amount of \$413,916.55; Wagg Place Storm Sewer 17-MYCW-19-00073 in the amount of \$8,832.00; Carroll Avenue Storm Sewer 17-MYCW-19-00074 in the amount of \$687,744.00 and Street Reconstruction MYCW-2017-2020 in the amount of \$382,808.00.

RECREATION & COMMUNITY SERVICES

Councillor Walsh advised that the committee did not meet, however, she gave an update on the following items: rentals, programs, special events are back on schedule at Pasadena Place; afterschool program is going well; outdoor rink is operational off and on as weather permits; gave update on grant applications and the Town will host weekly family entertainment on our outdoor stage for 8 weeks this summer.

Councillor Brake advised that unfortunately the fat bike race had to be cancelled. She also advised that the trail conditions have been impacted by with the recent weather and therefore maintenance will have to be done after the snow goes.

CHIEF ADMINISTRATIVE OFFICER REPORT

Mr. Hudson advised that the splash pad project is currently out for request for proposals for prime consulting and he also noted that due to the reorganization of the town there are three positions now posted for the Town of Pasadena.

Councillor Decker advised that MNL will be holding a symposium May 4 - 7 in Gander; Multi-Material Stewardship Board is having a webinar on March 11th concerning recycling and Job Creation Partnerships and summer student funding was announced today.

Councillor Brake inquired about the antique car show and the triathlon. She was advised that the dates of these events were unknown at this time.
