## **COMMITTEE REPORTS**

## FINANCE & ECONOMIC DEVELOPMENT

Deputy Mayor Randell reported that the committee met on August 9, 2022. The following items were discussed: committee structure; terms of reference; communication policy; busker policy; human resources; town news letter; branding and review of financials.

Decker / Brake be it resolved that Deputy Mayor Randell, Councillor Hall and Councillor Walsh are not in a conflict of interest in relation to payment made to Strawberry Festival on July25, 2022 - Cheque #37304.

114-22 Randell / Brake be it resolved that approval be given to approve payment of cheque #'s 37297 to 37364 in the amount of \$339,641.26.

Councillor Cormier advised that the committee met on August 8 and the following items where discussed: fleet renewal; water plant; flushing schedule; fire hydrant repairs; sewage lagoon; roads; sidewalk repairs; beach clean up; maintenance on walking trails, boat launch, dog park, playgrounds, community garden and radar signs. Trees have been cut back at Blue Gulch Brook, security cameras are working to determine if litter is being dumped, ATV routes signage has been put in place and old Christmas lights have been removed. They also reviewed land rezoning request, land developments, community service building, asset management, future capital works upgrades and municipal regulations,

Hall / Cormier be it resolved that the Town of Pasadena amend the Recreational Vehicle Regulations as presented.

- \$93,653 for Water Treatment Plant Upgrades UV Light Treatment
- \$364,337 for Street Reconstruction
- \$272,050 for Seaward Park Upgrades
- \$97,000 for Sewer & Storm Sewer Condition Inspections
- \$95,000 for Comprehensive Development Design Plan for Future Development Growth

## **RECREATION & COMMUNITY SERVICES**

Councillor Walsh advised the committee met on August 9, 2022. Items discussed were: room rentals and fitness center users are down due to the time of year; maintenance of recreation facility is ongoing; summer camps are doing well; new swings will be installed in September; observance of Pasadena civic holiday for Pasadena Place employees; application put in for three grants; Come Home Year Festival was a great success and thanks for all volunteers; first aider on Pasadena beach when weather permits; possibility of having electric bike rentals and upcoming fall programs are being discussed.

#### CHIEF ADMINISTRATIVE OFFICER REPORT

Councillor Walsh inquired when work will begin on Forest Road and Tamarack Avenue. Mr. Hudson advised that there will be a meeting on Friday with consultants so hoping to have some details on construction timeline.

Director of Engineering is looking into cost for the outdoor rink.
