# Municipal Plan/Development Regulations

Rezoning of several properties were discussed:

- Application for a new expanded municipal boundary to include all current planning boundary area (with exception of Pynn's Brook) and the area known as Boom Siding
- Recommend Council approve the municipal stewardship agreement

## Other Business

- Communications tower installation near Transmission Pond recommended to proceed with water resources approval
- Pasadena Place building maintenance: repairs are required to address insurance risk assessment; committee recommended to proceed with roof repairs in the foyer areas that connect the gymnasium, multi-purpose and fitness center wings. Cost is estimated at under \$100,000 and this repair will trial as a permanent fix; work is ongoing with wood siding repair options; mechanical and controls contracts are in place
- · Fire department roof repair being investigated
- CCTV for Blue Gulch Intake is being reviewed
- · Crown Land applications are being reviewed for submittal
- Voyent Alert emergency and community app is being finalized for promotion
- Subdivision/development progress updates were provided
- Costing of sidewalk from South Brook bridge to Adam Crescent is being reviewed

Councillor Decker adjourned the meeting at 8:41pm.

Councillor Decker presented the following resolutions:

## **PUBLIC WORKS & PROTECTIVE SERVICES**

Councillor Hall advised that the committee did not meet. However, he did have updates on the following issues: the water filters at the plant have been changed; public works is ready for winter; hauling salt will start in November; maintenance is scheduled for sewage lift pumps; lime is ready to be put on fields; and docks were hauled out before the storm and are now put back in place.

#### **RECREATION & COMMUNITY SERVICES**

Councillor Walsh advised that there was no meeting since last council meeting but did advise that everything is running smoothly.

#### CHIEF ADMINISTRATIVE OFFICER REPORT

Mr. Hudson advised council that the regulations pertaining to livestock, water/sewer and animal control should be ready for next council meeting. He also noted that the Grand Council Flag was raised on September 29th and it was a great success with many people in attendance.

#### QUESTIONS AND COMMENTS

Councillor Walsh advised that she attended the Grand Council Flag raising and it was great to see such a great turnout from the public.

Deputy Mayor Randell advised that he also attended the flag raising and it was a great success. He inquired when clean up week will start and Mr. Hudson advised that all bulk garbage has to be put to the curb by November 7, 2022.

Councillor Brake noted that it was nice to see the ATV regulations now put on social media. She did want to point out that dirt bikes are now required to have both front and back headlights.

Councillor Decker advised that he attended the Truth & Reconciliation Day in Corner Brook on September 30, 2022. He was at a loss of words to express how he felt about the destruction that was done to the South Coast

by Fiona. He also advised that October 1 - 7 was Energy Efficiency Week and that Council has now been in office for one year.

Mayor Gardner advised that both himself and Mr. Hudson were in St. John's last week and met with the Honourable John Hogan, Minister of the Department of Justice and Public Service. They discussed community policing, fire ruck application and issues with the current 911 system. They also met with Dept. of Municipal Affairs and discussed our planning area and boundary extension.
