INFRASTRUCTURE, ENGINEERING, PLANNING

Councillor Decker advised that the committee met on December 12th and the following was discussed: purchase of 12 Third Avenue was completed today; energy report for Pasadena Place has been completed; roofing work at Pasadena Place has been delayed until the Spring due to weather; planning for capital works projects are ongoing and more residents are now registered for Voyant Alert and hopefully more will continue to register. Councillor Decker presented the following resolutions:
