 - Plaster starting this week. Discussed possibility of completion date of middle to end of June 2023.

Councillor Decker also advised that the splash pad has been ordered from the supplier. He also noted that the paving project has been awarded to Marine Contractors and start date to be June 13, 2023.

RECREATION & COMMUNITY SERVICES

Councillor Walsh reported on the following notes of committee meeting held on May 23, 2023.

- Review of previous minutes - April 24, 2023
 - A grant for \$7000 has been received for the new Pre-K part-time program and Sport and Adventure Camp. We are hoping to offer the Pre-K program for \$20-\$25 for 12 sessions with session details to be finalized at a later date. It was suggested by Councillor Brake that we use some of this funding and make our summer camp program more affordable. Director Wight alluded to the fact that the funding will allow us to hire extra staff that will be shared with summer camp; therefore, keeping costs from being increased despite staffing costs. CAO Hudson noted that the greatest cost associated with our summer camp program was staffing; and while the minimum wage has increased this year, we only received funding for four students compared to six last year.
 - Director Wight pointed out that we have conducted research on summer camp programs in other towns and based on the structure of our program, our prices are on par with others with no increase since 2019.
- Recreation Programs
 - Director Wight noted that although programs are coming to an end for this season, we will continue to offer drop-in sport programs throughout the summer.

- Director Wight also noted that our Easter Camp program was a remarkable success with an average of 23 kids each day throughout the week.
- Recreation Rentals - School Sports Day Events
 - While most of our regular renters are finished for the season, several schools in the local area have booked our facility to offer sports day events and graduation ceremonies throughout the month of June. Renters include J.J. Curling Elementary, Pasadena Elementary, Pasadena Academy and Eastside Elementary in Corner Brook.
- Fitness Center – Memberships are on par with previous years.
- Accessible Fitness Center Request – Director Wight is still looking for funding options for fitness equipment.
- Special Events - Municipal Awareness Week was a great success with good attendance. Some of the events we offered included the following:
 - Mayor for a Day
 - Fire Chief for a Day
 - Touch-A-Truck
 - Outdoor barbecue
 - Facility tour with Grade 3 class of Pasadena Elementary
 - Facility tour with Social Studies 3202 class of Pasadena Academy
- Canada Day Planning is still in progress. Staff at Pasadena Place is currently reviewing past years' events.
- Trails Committee Update
 - Councillor Brake suggested that the Town send out a letter to residents whose property is being used as a trail, namely the area on Hodder Drive and Birchview Drive being used by high school students, to see if there is interest in turning the land over to the Town in exchange for fencing around their property.
 - CAO Hudson noted that we need a plan for our new trails, and while the Green Team can be assigned to work on smaller jobs, the West Coast Group will work on the bigger projects.
 - CAO Hudson also suggested that we need a continuous audit/maintenance check performed on our existing trails for hazards and repairs.
 - Mayor Gardner mentioned the Train Station recently purchased from Mr. Ledrew. CAO Hudson noted that the overall project to have it removed from Mr. Ledrew's property, relocated, and renovated could have a project cost in excess of \$100,000. This could later be considered for a donation to the Heritage Society where grant funding could offset some of the expense.
- Grants Update – Director Wight advised that we received a \$10,800 grant from Canadian Heritage Society for Pasadena Days. This funding will be used by the Strawberry Festival Committee for entertainment events.
- The Hub/Community Services Facility – No updates on the Community Services Facility; however, Service NL did an inspection on the Library/Treehouse facility.
- Capital Works Projects – CAO Hudson announced that we received permission to buy the splash pad directly from the supplier. Tender will go out for labour and installation after we receive the splash pad equipment.
- Tenth Avenue Playground Swings – Public Works is being directed to install the swings during the week of May 29, 2023.
- Landscaping Scope of Work Contract – Humber Nurseries will be taking care of the landscaping this year.
- Town Bus - Day Trips and Events.
 - Special Events/Program Coordinator Cassidy Vallance has been researching bus policy from other Towns throughout the province.
 - A local school has requested for us to provide bus services for school events, but as Councillor Brake noted, schools are supposed to use school busses for such events.
 - Councillor Walsh pointed out that the bus is intended for community events.
- Pasadena Beach
 - Director Wight will be meeting with Cathy Garcin on May 24 to discuss beach operations for 2023.
 - Sand will be delivered for the beach courts during the first week in June.
 - New nets were purchased for the beach courts from grant funding.
- Electric Bike/Scooter Policy – while the policy is still under review, it was noted by Councillor Brake that we offer a call-out staff for repairs and tire changes. Mayor Gardner also noted that we display the bikes at the school for promotional purposes.
- Regulated Childcare/After School Program – We are awaiting Councillor Walsh to call a meeting with the Committee of the Whole.

- Summer Programs/Summer Jobs
 - Still waiting on more grants to come for summer programs/summer jobs.
 - Most of the hiring has been completed for summer positions.
 - Interviews are being conducted on May 24 for the Green Team positions.
 - Summer Camp registration is filling up, and as of May 23 we had an average of 27 kids registered for summer camp over 39 days.
- Baseball Meeting – A meeting was held between the Town and the Baseball Association, and it was determined that both parties need to build a better partnership and address the following concerns:
 - The Baseball Association would like to run a canteen.
 - The Soccer Association would be a consideration as a partner of this operation.
 - The Baseball Association should send requests to the Town when there is a need for mowing the grass and dragging the fields.
- Forest Road Playground – The playground structures were fully replaced and enhanced in 2016. At that time the new playground structures had been offered to Pasadena Elementary in order to expand recreational offerings in the community and to ensure greatest impact for children while only moving the playground site 185m from its original location. The new site at Pasadena Elementary never proceeded as the land was owned by the Roman Catholic Episcopal Corporation of St. George's whom did not provide permission for use. It is understood that the land usage issue has been rectified between the Episcopal Corporation and Pasadena Elementary. Pasadena Elementary may be interested in relocating the structures there. This item is for further discussion and no decision has been made.
- Director Wight announced there will be a Pride Walk held at 1:00pm on June 17, 2023 and the Town would donate \$100 to the group towards the purchase of water and hot dogs for a BBQ event.
- The public washrooms located at Tenth Avenue remain closed due to vandalism. Video surveillance was provided to the RCMP on May 2, 2023, and they will continue to investigate this matter. The Town has requested charges be laid if enough evidence can be found. Extensive repairs are necessary to make the washrooms operational again.
- The next meeting will be scheduled in June with a date to be determined.

PUBLIC WORKS & PROTECTIVE SERVICES

Councillor Hall reported on the following notes of committee meeting held on May 24, 2023.

- Discussed access to North Harbour Road and some restrictions that should be put in place for commercial vehicles.
- Sand and salt to be ordered for upcoming winter months.
- Fleet review - discussed replacement of aging equipment. Options of leasing verses financing.
- Water line issue at residence on Tipping Drive.

CHIEF ADMINISTRATIVE OFFICER REPORT

Mr. Hudson gave Council a brief overview of recently attended conferences, FCM and CAMA. He also advised that the Town is working with a private contractor whom has a contract with the provincial government to replace two culverts across the Trans Canada Highway near Pine Ridge Campground. He also noted that final review for storm sewer installations for Forest Road and Tamarack Avenue is expected to be finalized by the province this week. He also stated that we have been having an increase in water breaks over the last few weeks.
