#### COMMITTEE REPORTS

#### ADMINISTRATION, CORPORATE SERVICES & ECONOMIC DEVELOPMENT

Deputy Mayor Randell advised that there was no meeting however he presented the following motion.

**INFRASTRUCTURE, ENGINEERING, PLANNING**

Councillor Decker advised that there was no meeting however he updated Council on the following: preliminary design should be ready in near future for skating rink/swimming pool project; Dept. of Transportation & Infrastructure have reviewed documents for storm sewer project for Tamarack Avenue and Forest Road and the consultant is ready to revise and submit for tender call; water treatment plant upgrade commissioning will begin by mid August; Stantec have started work on the Dam Safety Study for the Blue Gulch Dam Intake Replacement Project; splash pad equipment has been pre-purchased by the Town; a third revision was received in the middle of June for the Comprehensive Development Plan and town officials are to meet with land owner; the CCTV inspections are continuing; Town is ready to engage a consultant for Lakeshore Drive, Tipping Drive & Maxwell Place phase II asphalt projects; prep work for paving has begun on Birchview Drive and Dawson Drive; nine building permits have been issued to date for new dwellings; Town is partnering with Food Cyler for a food waste composting project and some units have been ordered; Grenfell Campus Environmental Policy meeting scheduled for June 21, 2023 to look at a water use reduction study for the Town; Town plans to partner with electronics product recycling association to provide a drop off location for electronics and a meeting is scheduled for tomorrow June 20, 2023 to discuss paint collection strategy.
