RECREATION & COMMUNITY SERVICES

Councillor Walsh presented the notes from committee meeting held on September 11, 2023.

In Attendance: CAO Brian Hudson, Mayor Darren Gardner, Director of Recreation and Community Services Wanda Wight, Councillor Gemma Walsh, Councillor Carla Brake, and Administrator Leona Peach.

1. Review of previous minutes from August 1, 2023
 - Director Wight presented a quote and a drawing for a new playground near Harvey Wight Crescent.
 - Councillor Walsh suggested we get a quote for a bouncy pillow as an attraction for the park.
 - Councillor Brake suggested the new playground should be in the green space near the pump track on Pine Avenue.
2. Recreation Programs/Summer Program/ Fall Programs
 - We have been getting good reviews regarding the Playability Program being offered on Sunday afternoons.
 - There have been several inquiries regarding adult archery.
3. After School Program
 - With 11 children on the waitlist, consideration may be given to take all on our list.
 - Space and staff is being a challenge and interviews will be conducted soon.
4. Special Events - Responsibilities will be handed off to Coordinator Greg Whelan for planning and carrying out special events projects including Trunk or Treat, Bonfire Night, and Breakfast with Santa.
5. Recreation Rentals - Our rental schedule is full due to private rentals and our programming.
6. Fitness Center - Memberships are up based on previous years.
7. Pasadena Days/Festival - Director Wight is coordinating a meeting with the Festival Committee and the Recreation Committee to discuss their concerns regarding the Town's role in festival events.
8. Trails Committee Update
 - Grant funding from last year is being used to complete the up trail by December 2023.
 - Public Works will supply the labor for the completion.
9. Grants Update - Director Wight noted grant reports for summer programs are due this month. There is \$7500 in grant funding which will be spent on slides for the Pine Hill Nature Park this month.
10. The Hub/Community Services Building
 - Plumbing will begin this week.
 - CAO Hudson noted that the concrete lines have been cut, ground work is being executed by Town staff, and wall studs will begin this week as well.
11. Capital Works Projects - splash pad, pool, Seaward Park upgrades - no updates to report.
12. Town Bus
 - The first ride scheduled for Corner Brook on August 31 was rescheduled to September 6 due to lack of registration; however, interest is growing.

- We need a new approach to advertise to seniors who don't use social media.
- A field trip is planned to take seniors to the Lark Harbor area for a day in September.

13. Pasadena Beach

- Director Wight noted there will be a follow-up meeting with Cathy Garcin to review partnership/operations in 2023.
- Director Wight also mentioned the vandalism which occurred at the beach over the weekend.

14. Electric Bikes/Scooters Rental

- CAO Hudson suggested we charge a lower price for less time.
- Mayor Gardner noted we need more advertising.
- Leona will make necessary changes and work on advertising.

15. The following items arose during general business:

- a clock for the exterior of the building
- improvements to the soccer field including leveling and aerating the sod
- an autism playground at the beach
- floating islands for the beach
- a club house facility for all users of the ball fields on Tenth Avenue
- work on the nature playground will resume this fall, and Director Wight will look into drawings for the play stations
- budget items to be considered include an ABI Force for the sports field
- CAO Hudson suggested depot staff assigned to recreation should report to Director Wight during the four months of summer

PUBLIC WORKS & PROTECTIVE SERVICES

Councillor Cormier advised that on September 7, 2023 the committee met with RNC Staff Sargent Ryan Wentzell. The meeting was to briefly discuss the upcoming transition for the policing of the Humber Valley Region.

She also noted that the annual Terry Fox Run will be taking place at Pasadena Elementary this upcoming Friday.

Councillor Decker advised that he attended a meeting with Mountain Bike Atlantic to discuss mountain biking in the Humber Valley. He also noted that our Director of Recreation and Community Service, Wanda Wight, was also in attendance.

Councillor Hall expressed that he hopes that all residents had a great summer as the first day of fall is September 23, 2023.

Councillor Walsh noted that Pasadena Place has a great Friday night event program for youth which is a success. She also noted that the Pasadena Army Cadets are looking for new recruits and would like to see more youth involved in this great program. She also asked that drivers drive carefully now that the evenings are much shorter and asked that people shop local.

Councillor Cormier noted that Truth & Reconciliation Day is September 30th and asked that everyone take a few minutes and ask themselves what it means to them.

Deputy Mayor Randell wanted to remind residents that Pasadena Place has their electric bikes and scooters for rent. He also advised that he attended a trip on the town bus to the insectarium and it was a great success. Some members of the Strawberry Festival met with Parliamentary Secretary for Canadian Heritage Chris Bittle and discussed difficulties facing local festivals and recruiting more volunteers. He advised that the GHJC will hopefully be holding their next meeting next month. He also received a letter with a complaint about speeding around school zones and he asked that drivers to be extra cautious in these areas. Work at the library, family tree house and the Hub are progressing well.
