Councillor Decker advised that the committee met on February 26, 2024 and reported on the following:

  - project came in over budget, discussed cost savings options. Waiting for revised estimates.
- Floating Dock Equipment
  - working on procurement options
- Recreation Facilities Update - Skating Rink and Swimming Pool
  - project overbudget - discussed cost savings options
- Dam Replacement Project
  - submitted scope change to TI, received approval now will advertise for a consultant
- Community Services Building/Pasadena Health Center Update
  - now operational, construction still ongoing on back section of the building. Work should be completed by end of March or early April
- WTP Upgrades
  - project is complete apart from installation of backup generator which will be install in the Spring

  - Town is looking at options to add additional industrial space

  - discussed vacant land as potential green space

  - developer has approached the Town with regards to expanding industrial/commercial space

## RECREATION & COMMUNITY SERVICES

Councillor Walsh advised the committee met this afternoon and reported on the following:

- Review of previous minutes January 22, 2024 - no issues or changes
- Recreation Winter Programs
  - Registration and drop-in numbers are still high in programs including preschool, kick boxing, indoor soccer, and ball hockey.
  - Details for Easter camp have been finalized and will be posted on Facebook immediately.
  - There has been a request for a men's ball hockey program, but given the risks associated with the sport, we suggest offering it to an outside organization to operate in our space.
- E-Services
  - Registration for all four youth programs in March was available through e-services and also for two of the five adult programs. The other three adult programs were for senior participants who are less likely to register through e-services.
  - E-services registration will not be made available for rentals or drop-in programs at this time.
- Special Events
  - Director Wight recently completed a grant for the 75th Anniversary of Confederation. Upon approval, this grant will be used to fund events from July 1 through July 15. Pasadena Heritage Society also applied for funding, and we will work together for event planning if successful.
  - Due to positive reviews, another cornhole tournament is scheduled for Saturday April 6. It will coincide with the cornhole offering to Easter Camp participants as well as the Seniors Social program on Friday April 5. More details to follow.
  - Director Wight is working with Recreation Coordinator Programmer Gregory Whelan to organize new special events during the upcoming months.
- Recreation Rentals
  - Our rental calendar continues to be filled each month for the gymnasium and multi purpose rooms.
  - We will continue to offer rental time/space to the same user groups who have been loyal to Pasadena Place over the years.
- Fitness Center
  - Memberships are on par with previous years.
  - We received correspondence requesting the committee to consider an option of a gym membership rate for rotational workers. The option was discussed, and the committee decided to keep the membership rates as they are. The committee felt the options to purchase ten-day passes or a membership package should accommodate most rotational workers' schedules. In addition, with so many different rotational schedules, tracking usage would be very time consuming for front desk staff.
- Pasadena Days - Festival - no updates at this time.
- Trails Committee Update - no updates at this time.
- Grants Update
  - Director Wight submitted a grant for Accessible Communities to obtain funding for specialized fitness center equipment as well as automated doors for the Community Services Building.
  - The following grants have been completed: Greener Jobs, Student Employment, Green Team, and the 75th Anniversary of Confederation.
  - The Program Coordinator was successful with a recent application securing \$500 for a Teen Challenge grant through Recreation NL.
- Pasadena Medical Center
  - The gymnasium at the new facility is expected to open Thursday April 4. Recreation staff will look at moving some current programs to the new building which will allow gymnasium space to become available at Pasadena Place.
  - Pasadena will be hosting the Urban Municipalities Conference on April 6. A tour of the new medical center is planned on that day.

- Chairperson Walsh mentioned the local Beaver Group was looking for space for weekly meetings. If they wish to book meeting space at Pasadena Place or the new building, the rate will be consistent. They will be advised to call the front desk for more information.
- Capital Works Projects - splash pad, pool, Seaward Park upgrades
  - Construction on the splash pad is expected to begin in April.
  - Construction on the pool has been cancelled at this time.
  - The rink project at Seaward Park is currently under review.
- Town Bus
  - Due to a lack of participation in the Tuesday Shop Local, we decided to end the program.
  - Even though the numbers are low for the Corner Brook trip on Thursdays, we will continue to offer this service.
  - We are currently working of different uses for our Town bus including trips to Deer Lake and Corner Brook for our program participants.
- Corner Brook cruise ship schedule
  - Mayor Gardner advised that with thirty-seven cruise ships arriving in Corner Brook this year, Councillor Decker will enquire into the process for submitting a proposal for offering a program to the Cruise Coordinator. This is an opportunity to bring tourists to Pasadena Beach, have them shop local, and eat in local food establishments.
- Food Hub Community pick up locations
  - After consideration, The Town of Pasadena will not be participating in this program due to space, time, and staffing constraints.
- Recreation NL will be hosting their AGM and Conference in Corner Brook on April 26 and 27. Director Wight will forward the agenda to all councillors.
- Director Wight will follow up with Training Officer Lorne Reid of the Pasadena Army Cadet Corp 2959 regarding hosting a Council meeting/event at Pasadena Place on April 15 for their members to attend.

Councillor Brake advised that the Trails and Green Space Committee met last night. There has been a public call of interest for individuals who may like to become a committee member. They also discussed the need for ATV safety promotion with additional signage being a good way to help this issue. Mayor Gardner advised that there was a meeting with ACOA and funding may be available for helping with way finding signage cost. The committee also noted the need of portable toilets for Sandy Cove and South Brook Point beaches.

## **PUBLIC WORKS & PROTECTIVE SERVICES**

Councillor Cormier advised that there has been no committee meeting since the last regular meeting of Council.

## **CHIEF ADMINISTRATIVE OFFICER REPORT**

Mr. Hudson gave an update on environmental approval for Corner Brook Pulp and Paper for their five year operating and harvesting plan for Zone 6 which is in the Pasadena area. The environmental assessment was approved by the Minister. The Town has reached out to Corner Brook Pulp and Paper to discuss some potential issue we may have from a development and environmental perspective.
