#### COMMITTEE REPORTS

#### ADMINISTRATION, CORPORATE SERVICES & ECONOMIC DEVELOPMENT

Deputy Mayor Randell advised that the committee has not met since the last Council meeting however the committee will be meeting Monday April 22, 2024. He presented the following resolutions:

**RECREATION & COMMUNITY SERVICES**

Councillor Walsh advised that the committee met today, April 15, 2024 and provided the following updates:

Winter programs are close to being finished for the year, as well discussions were had regarding upcoming special events of Strawberry Days. Rentals at Pasadena Place are great and fitness center memberships are on par from previous years. Discussed capital works projects including the Splash Pad anticipated opening this summer and encouraging continuous involvement in our community garden. The committee also discussed approval of several recreation grants, including grants for summer employment and other recreation activities. Councillor Brake added that the South Brook trail is set to re-open on April 25, 2024.

**PUBLIC WORKS & PROTECTIVE SERVICES**

Councillor Cormier advised that the committee has not met since the last Council meeting however the committee is scheduled to meet on Monday April 29, 2024.

**CHIEF ADMINISTRATIVE OFFICER REPORT**

Mr. Hudson noted that construction will begin tomorrow April 16, 2024 on Forest Road for storm sewer and sidewalk installation. This project while it is commencing tomorrow, is expected to conclude by the first week of July and at that time Marine Contractors will move on to Tamarack Avenue and begin storm sewer and sidewalk upgrades then with final completion set for the first week of October. He also noted that they are expecting to have a pre-construction meeting before the next regular Council meeting to discuss the construction start date for the splash pad, but it is expected to commence within the next thirty days.

Mr. Hudson provided updates on the Tipping Drive, Lakeshore Drive and Maxwell Place capital works upgrades. He also explained capital works cost share between the town and the provincial government.

He also noted that we have several openings for summer student employment mainly for recreation and public works.

Councillor Cormier reminded residents of our annual spring clean up which is set for the week of April 29, 2024. He also provided updates regarding the Corner Brook Pulp and Paper stating the mill will be producing paper soon and that there are employment opportunities for any individuals who wish to apply.

Councillor Walsh welcomed and thanked the 2959 Pasadena Lions Royal Canadian Army cadets in their attendance to this evenings Council meeting. She also congratulated team NL men's curling for their Grand Slam of Curling win this past weekend.

Councillor Brake advised that if anyone would like to provide input, comments or suggestions regarding Council decisions they are welcomed and encouraged to do so. She noted that the grade three and four classes hosted a basketball tournament at Pasadena Academy this past weekend which had a great turn out and was a success.

Councillor Decker advised that it is National Volunteer and National Tourism week. He expressed the importance of volunteers and tourism in all communities around the province.

Councillor Hall congratulated everyone who participated in the marksmanship this past weekend.
