The underground work for the Tamarack Avenue Storm Sewer project will be completed soon, once completed the curb will begin. Also, the Splash Pad underground work has been completed and concrete will be poured this week. Expecting drawings from consultant this week for the Lakeshore/Tipping/Maxwell Drive project and the geotechnical work has been completed for the Blue Gulch Dam Replacement project.
